ISC BECAME ONE OF THREE NATIONAL PARTNERS FOR THE U.S. ENVIRONMENTAL PROTECTIONS AGENCY'S (EPA) ENVIRONMENTAL JUSTICE THRIVING COMMUNITIES TECHNICAL ASSISTANCE CENTERS (EJ TCTAC) PROGRAM IN THE FALL OF 2023.
